

Resolution

BE IT RESOLVED by the Council of the White Mountain Apache Tribe of the Fort Apache Indian Reservation, in regular meeting assembled on 1 May 1950 as follows:

That Nelson Lupe, Chairman of such Council is authorized and directed to execute on behalf of such Tribe those certain amendments to its attorneys' general representation contract with James E. Curry and C. M. Wright which are specified in the document attached hereto and made a part of the minutes of this meeting.

The foregoing resolution was on 1 May 1950 duly approved by a vote of 10 for and 0 against, by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article VI, Section 1 (b), of the Constitution of such Tribe, ratified by such Tribe on 15 August 1938, and approved by the Secretary of the Interior on 26 August 1938, pursuant to Section 16 of the Act of 18 June 1934 (48 Stat. 984).

Amendments to attorneys' general representation contract

The attorneys' general representation contract, executed under date of 30 December 1949 by Fred Larzelere on behalf of the White Mountain Apache Tribe as client, and by James E. Curry under date of 13 December 1949 and C. M. Wright under date of 15 December 1949 as attorneys, is hereby amended as follows and not otherwise.

1. By deleting from paragraph 2 thereof the 4th sentence which read as follows:

"The Associate Attorney and each and all of the Assistant Attorneys bind themselves faithfully to observe all reasonable and proper instructions and directions of the Chief Attorney in all matters affecting their duties hereunder."

2. By deleting the words "of the choice of counsel and of the compensation herein fixed" appearing in paragraph 3 thereof.
3. By inserting the word "legal" immediately before the word "matters" appearing in paragraph 5 thereof.
4. By inserting the words "in advance" immediately after the word "authorized" appearing in paragraph 7-d thereof.
5. By deleting the words "thereof among the other attorneys" appearing in paragraph 8-b thereof; and by inserting in lieu thereof "to the Associate Attorney".
