FORT APACHE INDIAN RESERVATION

WHEREAS, by Resolution No. 60-59 the Tribal Attorney's expenses and travel allowance was increased from \$1,500 to \$2,400, and


WHEREAS, in the Tribal Budget 1960-61 the sum of \$900 as and for extra legal fees which sum is provided in the approved Tribal Attorney's contract was inadvertently omitted from the said budget.

BE IT RESOLVED that Section I (1) of the Fiscal Year 1960-61 Tribal Budget be amended by including the sum of \$900 therein as and for extra legal fees for the Tribal Attorney.

The foregoing resolution was on April 17, 1961 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

This Resolution amends Section I (1) of the Tribe's general budget of the White Mountain Apache Tribe for Fiscal Year 1961 by appropriating \$900.00 for extra legal fees for the Tribal Attorney.

This Resolution was passed by the Tribal Council on March 30, 1961 but was not submitted to the Superintendent within the 10-day time limitation.

Under provision of Article V Section I (k) of the Amended Constitution of the White Mountain Apache Tribe this Resolution is subject to approval of the Secretary of the Interior.
