


RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, Section I (b) of the Fiscal Year 1961 Tribal Budget provided \$4,000.00 pay and travel expenses of Council Members on authorized trips and \$1,200.00 travel expense for the Council Chairman, and

WHEREAS, because of necessary extensive travel these amounts are found to be insufficient for Fiscal Year 1961.

BE IT RESOLVED that the sum of \$4,000.00 and \$600.00 is hereby appropriated from tribal funds on deposit in the United States Treasury to cover these two sub-items respectively.

The foregoing resolution was on April 17, 1961 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Attached is Tribal Resolution No. 61-33(a) adopted by the Tribal Council on April 17, 1961.

This Resolution amends Section I (b) of the Tribe's general budget for Fiscal Year 1961 by appropriating \$4,600.00 from Tribal Funds on deposit in the United States Treasury. This Resolution was passed by the Council on March 30, 1961 but was not submitted to the Superintendent within the 10-day time limitation.

Under provisions of Article V Section I (k) of the Amended Constitution of the White Mountain Apache Tribe this Resolution is subject to approval by the Secretary of the Interior.
