

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, by Resolution No. 61-38 adopted March 30, 1961 the White Mountain Apache Tribal Council appointed Mr. Paul Simmons as Tribal Treasurer and directed that he secure surety bond in the amount of \$75,000, and

WHEREAS, Section 4 (d) of the amended By-Laws of the White Mountain Apache Tribe approved May 29, 1958 and adopted by the voters of the White Mountain Apache Tribe on June 27, 1958 require that the tribal chairman shall countersign all checks with the Tribal Treasurer, and

WHEREAS, the Standard Accident Insurance Company, Detroit, Michigan has issued bond in the amount of \$75,000 for Mr. Paul Simmons, Tribal Treasurer and in the amount of \$10,000 for Mr. Lester Oliver, Chairman, as co-signer.


BE IT RESOLVED that the bonds issued by the Standard Accident Insurance Company to cover Mr. Paul Simmons and Mr. Lester Oliver are hereby approved.



Dear Mr. Haverland:

Resolution No. 61-47 was adopted by the White Mountain Apache Tribal Council on May 23, 1961 pursuant to authority vested in it by Article V, Section 1 (1) of the Amended Constitution and Article I, Section 4 (a), (c) and (d) of the Amended By-Laws of the Tribe.

This Resolution approves Bond No. B-127301 issued by Standard Accident Insurance Company, Detroit, Michigan, in the amount of \$75,000 covering Mr. Paul Simmons as Tribal Treasurer of the White Mountain Apache Tribe whose appointment was made by Resolution No. 61-38 adopted March 31, 1961. It also approves bond in the amount of \$10,000 on Bond No. B-127304 for Mr. Lester Oliver, Council Chairman, as co-signor on all tribal checks with Mr. Simmons.

Under the authorities cited this Resolution is not subject to rescission but under the provisions of Article I, Section 4 of the Amended By-Laws of the Tribe, the bonds are subject to approval by the Commissioner. I recommend approval as submitted.
