WHEREAS, they have submitted rough sketches of the tracts of land upon which they wish to build their houses, and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has no objection to the use of these tracts of land by these individuals.

BE IT RESOLVED that the members of the Tribal Council of the White Mountain Apache Tribe do hereby approve and grant a homesite lease to each of the above listed couples or individuals for a period of twenty-five (25) years at a rate of \$12.00 per year payable in advance on the first day of the month following the effective date of the lease with an annual payment of a like amount on the same date each year thereafter in accordance with the terms of the lease for as long as the lease shall run.

BE IT FURTHER RESOLVED that the Tribal Chairman shall execute said leases for and on behalf of the White Mountain Apache Tribe in accordance with Tribal Ordinance No. 44; the effective date of the commencement of said leases being the date of the approval of the loan by the Secretary of the Interior or his designated representative.

BE IT FURTHER RESOLVED that should any of the above loans not be approved within ninety (90) days from the date hereof, the respective leases shall thereby automatically terminate.
