

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribe has several employees classified as General Schedule equivalent.


WHEREAS, the Federal Government has granted raises to all Federal employees effective July 5, 1964.

WHEREAS, the Council is of the opinion that certain of its employees are entitled to a salary increase.


BE IT RESOLVED that the positions named in Exhibit A attached hereto and by reference made a part of this resolution be granted a wage increase as provided in Exhibit A, effective the 5th day of July, 1964.

BE IT FURTHER RESOLVED that the Tribal Budget be amended by appropriating the sum of \$5,548.02 from Tribal funds to cover the cost of the increase in salaries.

The foregoing resolution was on December 2, 1964 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
