

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, Resolution No. 64-5 enacted on January 8, 1964 approved lease rental fees covering lands occupied by traders for business and residential purposes.

WHEREAS, after further negotiations with R. Donald Kirkpatrick, dba Apache Bakery, it was the opinion that the percentage fee of gross income was excessive.

BE IT RESOLVED that Resolution No. 64-5 be amended by establishing a fee of 1% instead of 1½% of the gross income for R. Donald Kirkpatrick, dba Apache Bakery.

BE IT FURTHER RESOLVED that an annual rental fee of \$150 is established for lands occupied by Michael Palambas for residential purposes.

BE IT FURTHER RESOLVED that the Chairman of the Tribal Council and the Superintendent of the Fort Apache Agency are hereby authorized to execute any and all leases pursuant to Ordinance No. 49 for a period of ten years with an option to renew for an additional ten-year period to the following persons doing business and/or residing on the Fort Apache Indian Reservation:
