

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, it appears that various accounts in the Tribal Budget for the Fiscal Year 1963-1964 will need funds in addition to amounts originally anticipated, in order to adequately protect, preserve, and develop reservation resources, human or material, and

WHEREAS, there has been savings in various other accounts which are more than sufficient to provide the above required additional funds.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Budget for the Fiscal Year 1963-1964 be amended by transferring funds in the total amount of \$11,450.00 in accordance with the following schedule:
