

**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

WHEREAS, a Fort Apache Oil and Gas Lease Sale was conducted at the Fort Apache Agency Conference Room, Whiteriver, Arizona, on the 10th day of August, 1964, at 2:00 o'clock P.M., and

WHEREAS, said sale was advertised and conducted pursuant to regulations promulgated by the Secretary of the Interior, 25 C.F.R. 171 (Act of May 11, 1938; 25 U.S.C. 396) and White Mountain Apache Tribal Resolution No. 66-77, and

WHEREAS, all tracts of land were offered subject to acceptance of bids by the Tribal Council of the White Mountain Apache Tribe; with the further right reserved to reject any and all bids and to disapprove any lease submitted on any accepted bid, and

WHEREAS, the United States Geological Survey has made its recommendations as to said sale which recommendations were concurred in by the Area Office of the Bureau of Indian Affairs, and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has given due consideration to the bids offered and the recommendations made, and

WHEREAS, it is deemed to be to the best interests of the White Mountain Apache Tribe and the Apache Indians that the recommendations of the United States Geological Survey be followed.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the following bids be, and the same are hereby approved and accepted:

BE IT FURTHER RESOLVED that the Superintendent of the Fort Apache Agency is hereby authorized and directed to have prepared on Standard Form 5-157, Oil and Gas Mining Leases, Tribal Indian Lands, with appropriate modifications and additions, in favor of the Tenneco Oil Company and for the tracts mentioned above. Said leases to be prepared in accordance with existing laws and regulations.

BE IT FURTHER RESOLVED that when such leases are so prepared, the Chairman and Secretary of the White Mountain Apache Tribal Council are authorized and directed to execute said leases on behalf of the White Mountain Apache Tribe.

The foregoing resolution was on August 17, 1966 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (1) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
