

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, Arthur Gordon, Raymond Endfield, Raymond Kane, Roger Lupe, Luke Williams, Armstrong Billy and Jones Adley have applied for tribal loans for home construction, and

WHEREAS, a homesite lease is requested for each by Section 23 (e) II of the Declaration of Policies and Plan of Operation approved September 18, 1963, and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has no objection to use of the land by these individuals, and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has no objection to the lessors mortgaging the leasehold improvements to the White Mountain Apache Tribe Revolving Credit Program.

BE IT RESOLVED that the members of the Tribal Council of the White Mountain Apache Tribe do hereby approve and grant homesite leases to Arthur Gordon, Raymond Endfield, Raymond Kane, Roger Lupe, Luke Williams, Armstrong Billy and Jones Adley for a period of twenty-five (25) years at the rate of \$12.00 per year payable annually in advance on the first day of the month following the effective dates of the leases with annual payments of like amount on the same date each year thereafter in accordance with the terms of the leases for as long as the leases are in effect.

BE IT FURTHER RESOLVED that the Tribal Chairman shall execute said leases for and on behalf of the White Mountain Apache Tribe in accordance with Tribal Ordinance No. 44; the effective dates of the commencement of said leases being the dates of the approval of the loans by the Secretary of the Interior or his designated representative.

BE IT FURTHER RESOLVED that should an assignment have been made on a lot which is hereby leased to any of the above individuals, the lease shall automatically cancel the assignment.

BE IT FURTHER RESOLVED that the Tribal Chairman shall approve the Leasehold Mortgage mortgaging the improvements to the White Mountain Apache Tribe Revolving Credit Program!

BE IT FURTHER RESOLVED that should the loans not be approved within one hundred eighty (180) days from the date hereof, the lease and approval of right to mortgage the leasehold improvements shall thereby automatically terminate.
